




# What is an endowment? How does it work at the EFSC Foundation?



#### Endowed Scholarship:

The college invests the donated funds and only the interest generated is used to award scholarships. The capital is never touched, ensuring that the donor's gift is a permanent source of funding.

#### ► <u>EFSC Spending Plan:</u>

The plan permits expending 5% of the average of the previous 3 years net assets. This rolling average allows the foundation to maintain scholarship support during times of economic hardship, precisely when such support is needed the most.

## So even though.....

- ► As of June 30, 2017:
  - ► Corpus = \$80,000
  - ► Avg Value = \$116,758.24
  - Leaving = \$36,758.24



► We only will spend \$5,837.91 for the 2018-19 academic year to ensure the financial health of the fund
